



Application Form for Pre-Approval for a FarmReady Reimbursement Grant

The information you provide in this form will be used to decide whether you are pre-approved to attend your chosen course. You will need this pre-approval when you submit a claim for reimbursement (see below).

Pre-approvals are only valid for the specific course detailed in this form and expire 3 months after the Course Finish date or 31 May 2012, whichever comes first.

How do I complete this form?

- Answer all of the questions on the form
- Submit the completed form at least **5 working days** before your course starts
- Each form is for **one** person to attend **one** course – use separate forms for each person and each course

How do I claim my reimbursement?

- Finish the course we pre-approved you to attend
- Complete a **Claim Form** (not this form)
- Attach your evidence of completion (certificate), tax invoice and proof of payment (receipt) from the course, plus receipts for any associated costs you wish to claim
- Submit the form and all the supporting documents to FarmReady within **30 days** of the end of the course
- Keep a copy of all documents for your own records

How do I submit this form?

Forms must be submitted by the person attending the course or their employer. Forms cannot be submitted by a Training Provider.
